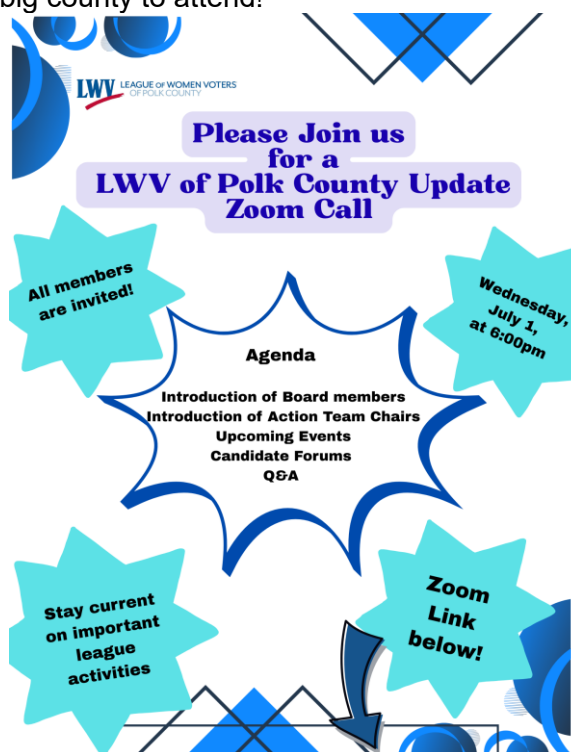

**Upcoming Polk County School Board Candidate Forum**

LWV Polk County is very pleased to join the NAACP-Lakeland Branch, LkldNow, the Polk County Voters League, and Alpha Kappa Alpha and other sororities to sponsor a forum for school board candidates in the upcoming election.

Incumbent school board member Lisa Miller, who represents District 7, is unopposed for another four-year term, but three of the seven county school board seats are being contested in nonpartisan races. Candidates for District 3 are Kate Wallace (appointed incumbent following the death of Rick Nolte), Sarah Corona, and Victor Sims. District 5 candidates are Kay Fields (incumbent) and Sam Neelam; and District 6 candidates are Justin Sharpless (incumbent) and Kasen Hampton.

Attendees should plan to arrive between 5:30 and 6 pm at The Well, 114 East Parker Street, Lakeland, with the program beginning at 6 pm (to include a few audience questions), and a meet and greet with the candidates from 7 to 7:30 pm.

Marjane Satrapi's acclaimed graphic memoir of an Iranian girl's struggles to survive under the repression of the shah, and after the 1979 revolution, the Islamic regime, **Persepolis** became the second most banned book in the US in 2014. A decade later, the book was swept up in Florida's book banning frenzy. Named after the ancient ceremonial capital of Persia, **Persepolis** is now banned in Hillsborough, Indian River, Union and Volusia Counties. ## Action Alley

The **League of Women Voters of the United States** has called upon all League members to oppose a new rule issued by the leadership of the US Postal Service (USPS) that would “establish elements of national standards for absentee and mail-in ballots in federal elections.”

This rule is problematic in several ways, not least of which is that it would give USPS a new role in carrying out elections--a role constitutionally reserved to states and localities. One consequence would be to disenfranchise eligible voters by actually allowing USPS to refuse to deliver certain mail-in ballots.
