LWVFL board of directors has predetermined that our first two priorities will be **voting** and **redistricting**. LWV FL will still have **four additional legislative priorities** that are in the process of being determined through a balloting process with local League boards. The 2022 legislative session begins on January 11, 2022.

LWV FL's various action chairs submitted areas of focus under each of their respective issues that they believe will be prominent within the area in the coming session. Members are welcome to review these suggested focus areas

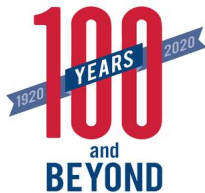

## *Action Alley*

In addition to the committee and action team goings-on reported on page 2 (“Overheard at the Last Board Meeting”), many additional activities are taking place.

Climate action committee chairs **Charlene Bennett** and **Karen Freedman** participate in LWV Florida’s regular statewide calls to share information. Committee member **John Wing** has served as a resource to Bok Tower staff considering going solar.

Healthcare committee members led by **Paula Mims** have assessed their progress in carrying out actions in relation to Medicaid Expansion, expansion of awareness of Polk County Indigent Healthcare Plan, assisting the March of Dimes in promoting maternal and infant health, a possible alliance with Monitors for Moms to increase access to blood pressure monitors, supporting **Eileen Swiler** with her work on reproductive health and justice, and creating one or more symposium-style events, for example, to bring representatives of various relevant agencies together.

Immigration committee chair **Natalie Alexich** has provided much education regarding LWV Florida positions on these issues, recognized the 9<sup>th</sup> birthday of DACA on August 15<sup>th</sup>, and given updates on legislative and legal decisions, as well as the possible economic and other consequences of these decisions. Currently, Florida has an estimated 23,650 DACA participants, and if the program is abolished nationwide, an estimated 685,000 workers would be removed from our economy, with a loss of \$460+ billion over ten years. US Citizenship and Immigration Services will open a new asylum office in Tampa in response to an increased need for these services. (Miami has been the location of Florida’s one such office prior to this.)

**Linda Donaldson**, membership chair, reports that LWV Polk currently has 105 members.

**Eileen** reports that Naples and Manatee County are considering adopting “Unborn Sanctuary City” status. Let her know if you hear of any talk of that in Polk County. Members are encouraged, as you do your shopping, to check Walgreens outlets to see if emergency contraceptives are on the shelves, as is required by law (as opposed to being kept behind the pharmacy counter).

## **Wanted: Gun Safety Chair**

Sadly, professional obligations have led **Sharon Hendon** to resign as chair of the gun safety committee. As Sharon stated in her resignation letter, “This committee is far too important not to have someone chairing it who can give it the full time and attention it needs and deserves.” We thank Sharon for her service and echo her words as we seek a new chair. Duties include becoming knowledgeable of the League’s positions on gun safety, available at [www.lwvfl.org](http://www.lwvfl.org); participating in LWV FL monthly calls with gun safety chairs across the state; and reporting to the board periodically.
