**Closing the Gap to Focus on Health and Mental Health**

Leading off on **March 3<sup>rd</sup>** will be **Diane Dimperio**, who has spent 35 years developing and managing health care programs with a number of entities in Alachua County including the UF College of Public Health and Health Professions. She is now a consultant and chairs the LWV FL’s healthcare action team. She will speak on the state league’s current positions. On **March 10<sup>th</sup>**, **Risdon Slate**, PhD, professor of criminology at Florida Southern College will present “From Deinstitutionalization/Criminalization of Mental Illness to Decriminalization via Medicaid Expansion.” Ris has been an advocate, trainer, speaker and consultant on a number of mental health and criminology initiatives at the local, state and federal level, and remains committed to de-stigmatizing mental illness.

On **March 17<sup>th</sup>**, LWV Polk past president and new healthcare committee chair **Paula Mims** and her committee will present LWV Polk’s positions on healthcare and the committee’s focuses going forward. Closing the Gap coordinator, LWV Polk past president and Speakers Bureau chair **Trudy Corry Rankin**, EdD, LMHC, 40-year counseling practitioner and host of this series, will join **Morgan Whitaker Smith**, LMHC, program manager of Peace River Center’s community action team (CAT) to speak to us about mental health care in Polk County on **March 24<sup>th</sup>**. **The fifth Wednesday in March (the 31<sup>st</sup>)** will bring us **Alice Koehler**, president and CEO of nonprofit Lakeland Volunteers in Medicine (LVIM). Alice will speak from her perspective of leading a large multi-specialty health care facility that provides high-quality, free medical, dental and mental health care to the working uninsured of Polk County, including her views on Medicaid expansion.

## League's New Emphasis on DEI: A Short History

The League of Women Voters of the US is actually a little late to the Diversity, Equity, Inclusion (DEI) "party," one of a number of facts that must be acknowledged as part of the process of moving forward.

It is well known that early Black suffragists were not treated equally by their White sisters. Ida B. Wells famously pushed her way to the front of a suffragist parade after she and other Black activists had been told to walk at the back. She also challenged her White colleagues in a failed attempt to get them to speak out against lynching. Sadly, she is the only Black suffragist whose name is widely known. But a recent book by the LWVUS' first Black president, Dr. Carolyn Jefferson-Jenkins, *The Untold Story of Women of Color in the League of Women Voters*, published last year, does much to correct that and charts in detail the evolution of League attitudes from its founding to the 100<sup>th</sup> anniversary of existence, 1920-2020. Now, the work continues as the national League elected Dr. Deborah Turner as its second Black president in 2020. Dr. Turner chaired the national board's DEI committee and recently contributed to the national League's blog post (see the link below).

Another landmark moment occurred in 2020, when the LWV US elevated DEI to the level of **policy**, a thing heretofore codified only for our nonpartisan stance.--*Katy Pace Byrd*

Zetkin proposed a special Women's Day to be organized annually and International Women's Day was honored the following year in Austria, Denmark, Germany, and Switzerland, with more than one million attending the rallies. . . . When the internet became more commonplace, feminism and the fight against gender inequality experienced a resurgence. Now we celebrate International Women's Day each year as we push continuously with the hope of creating a completely equal society."
